Each contractor that was reviewed was given a score of 1, 4, 7, or 10. The definition of that score is provided below

- 1 = poor performance, well below the Fonterra Standard, removal of contractor from site highly likely without immediate and significant improvement
- 4 = some areas below Fonterra Standard, discussion and agreement on Improvement required
- 7 = good performance, compliant to Fonterra Standards
- 10 = excellent performance, compliant to standards, showcasing the health and safety values with ability to model different scenarios

Your score at this stage from this review for the Reporoa site is a 10
